Overview

The National Summit on Preventing Civil Disturbances is designed to augment valuable contributions cited during two previous national meetings. Though local communities continue to struggle with celebratory riots and mixed-issue disturbances, much has been learned about successfully preventing such incidents. Built upon a solid foundation of evidence-based observations, the Summit will include action planning and solution building for campus and community.

Professional and knowledgeable participants will explore best practices in a variety of disciplines; contemporary perspectives regarding event management, alcohol abuse, local zoning and student involvement will be provided.

Sessions will include the following elements crucial to disturbance prevention: student leadership; campus-community cooperation; housing-zoning management; town-gown contributions; and business involvement. In addition, the Summit will explore innovative and practical techniques for special event management based upon case-related policing strategies and contemporary best practices.

Preventing civil disturbances requires a team effort and team attendance is encouraged. The Summit is specifically designed to benefit a variety of leadership teams to include: campus administration, police and student organizations; landlord and neighborhood representatives; city management, public safety, zoning and liquor officials; and social scientists.
